

ORDINANCE NO. 784

**AN ORDINANCE ESTABLISHING A RESTITUTION FUND FOR COSTS OF ARREST IN CERTAIN CASES, OF THE CODE OF ORDINANCES, IN THE CITY OF NEW FRANKLIN, MISSOURI.**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NEW FRANKLIN, MISSOURI, AS FOLLOWS:**

**Section 1.** Section 130.285 is hereby adopted to read as follows:


**Section 130.285 Costs of Arrest**

In any case in which the defendant admits guilt but no sentence is imposed, the defendant, as a condition of such disposition, may be required to make a restitution payment to the City of New Franklin for the costs of arrest and prosecution, in an amount not to exceed \$250.00. Such funds, upon receipt, shall be transferred to the general revenues of the City to be used to defray the budgeted expense of law enforcement and prosecution.


**Section 2:** It is intended that the provisions of Section 1 of this ordinance shall be incorporated into the Code of Ordinances of the City of New Franklin, Missouri.

**Section 3:** This Ordinance shall be in force and effect from and after its passage

- A. To pay a fee to compensate the County Collector and COUNTY for these services at a rate of Five Percent (5%) of the taxes which are collected by the COUNTY. The County Collector shall deduct such fee each month from the tax revenues collected for the CITY. The fee so retained shall be divided equally between the County Collector and HOWARD COUNTY. Two and One-Half Percent (2.5%) each.
- B. To pay a One and Seven Tenths of One Percent (1.7%) of ad velorem property tax Collections for deposit in the County Assessment Fund per Section 137.720.1, RSMo. Which began July 2009.
